KAEDAH-KAEDAH PENGAMBILAN TANAH (BORANG ELEKTRONIK) 2017

(2) Kaedah-Kaedah ini mula berkuat kuasa pada 1 Disember 2017.

LAND ACQUISITION ACT 1960

LAND ACQUISITION (ELECTRONIC FORMS) RULES 2017

IN exercise of the powers conferred by paragraph 69(*ba*) of the Land Acquisition Act 1960 [*Act 486*], the Minister, with the approval of the National Land Council, makes the following rules:

**Citation and commencement**

1. (1) These rules may be cited as the **Land Acquisition (Electronic Forms) Rules 2017**.

(2) These Rules come into operation on 1 December 2017.

**Electronic forms**

2. The forms specified in the Second Schedule of the Act, may be prescribed in electronic form as prescribed in the Schedule of these Rules.
