PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 7) 2017

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Selangor, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 7) 2017**.

(2) Perintah ini mula berkuat kuasa pada 27 November 2017.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala “Negeri Selangor Darul Ehsan”—

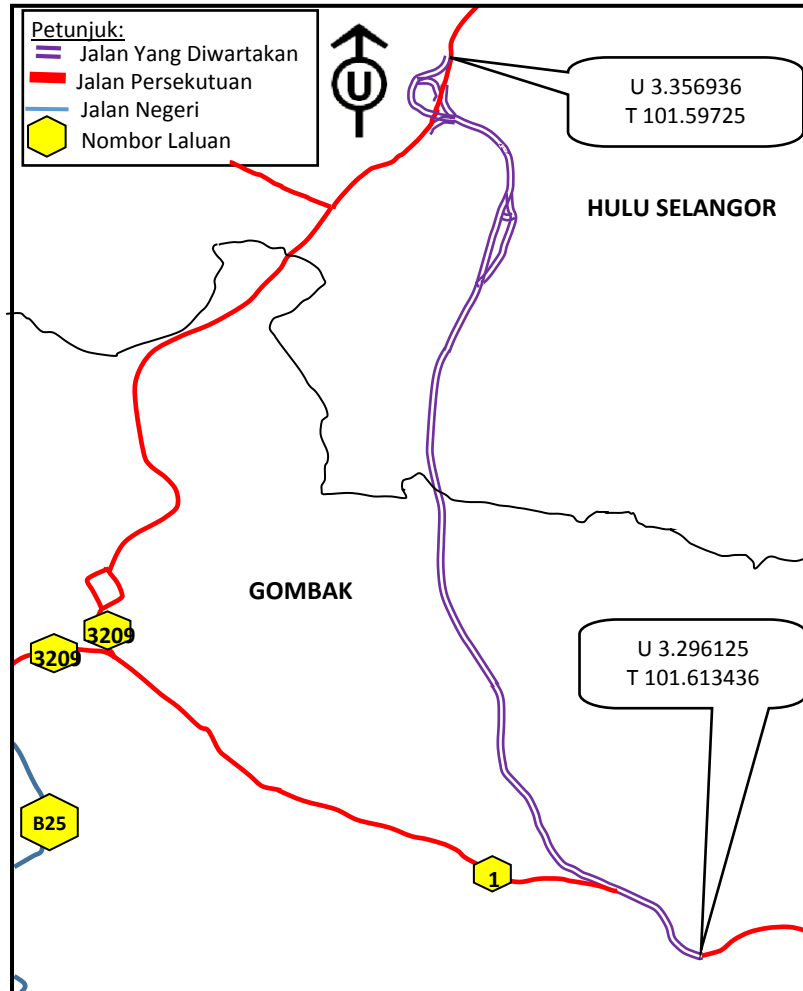
(a) dengan memasukkan selepas butiran 53 butiran yang berikut:

“54. (*Laluan 37*): *Jalan Rawang Bypass*

Dari Laluan 1 di koordinat U 3.296125, T 101.613436 dan berakhir di persimpangan dengan Laluan 1 di koordinat U 3.356936, T 101.59725 sebagaimana yang ditunjukkan dalam PETA 25: JALAN RAWANG BYPASS, NEGERI SELANGOR (jarak sepanjang 10.662 km).”; dan

(b) dengan memasukkan selepas PETA 24: JALAN-JALAN PERSEKUTUAN NEGERI SELANGOR peta yang berikut:

“PETA 25: JALAN RAWANG BYPASS, NEGERI SELANGOR

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 7) ORDER 2017

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Selangor, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 7) Order 2017**.

(2) This Order comes into operation on 27 November 2017.

**Amendment of First Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of “Negeri Selangor Darul Ehsan” —

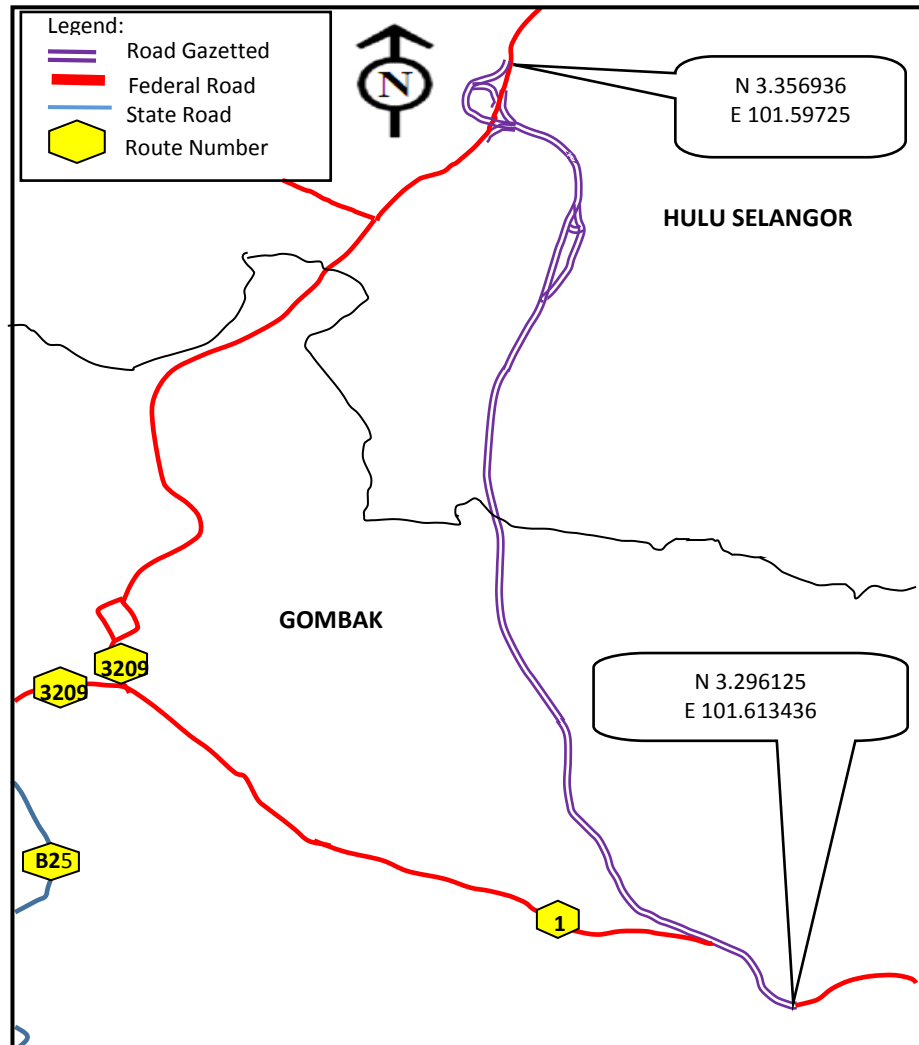
(a) by inserting after item 53 the following item:

“54. *(Route 37): Rawang Bypass Road*

From Route 1 at coordinates N 3.296125, E 101.613436 and ending at its junction with Route 1 at coordinates N 3.356936, E 101.59725 as shown on MAP 25 : RAWANG BYPASS ROAD, NEGERI SELANGOR (a distance of 10.662 km).”; and

(b) by inserting after MAP 24: FEDERAL ROADS OF NEGERI SELANGOR the following map:
