PADA menjalankan kuasa yang diberikan oleh subseksyen 69(2) Akta Pengangkutan Jalan 1987 [*Akta 333*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Had Laju Tempatan (Jalan Persekutuan) (Malaysia Barat) (Pindaan) (No. 2) 2017**.

(2) Perintah ini mula berkuat kuasa pada 13 November 2017.

Pindaan Jadual Pertama

2. Perintah Had Laju Tempatan (Jalan Persekutuan) (Malaysia Barat) 1992 [*P.U. (A) 462/1991*] dipinda dalam Jadual Pertama—

(a) di bawah kepala “NEGERI TERENGGANU”, dengan menggantikan butiran 35 dengan butiran yang berikut:

ROAD TRANSPORT ACT 1987

LOCAL SPEED LIMIT (FEDERAL ROADS) (WEST MALAYSIA) (AMENDMENT)
(NO. 2) ORDER 2017

IN exercise of the powers conferred by subsection 69(2) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Local Speed Limit (Federal Roads) (West Malaysia) (Amendment) (No. 2) Order 2017**.

(2) This Order comes into operation on 13 November 2017.

Amendment of First Schedule

2. The Local Speed Limit (Federal Roads) (West Malaysia) Order 1992 [P.U. (A) 462/1991] is amended in the First Schedule—

(a) under the heading “STATE OF TERENGGANU”, by substituting for item 35 the following item:

<i>Road name and location</i>	<i>Speed limit (km/h)</i>
“35 Route 106 - Ajil - Kuala Berang Road from Paya Besar junction N 5.073332, E 103.031571 to Bandar Ajil cross road N 5.082055, E 103.085755 (a distance of 6.30 km)	80”; and

(b) under the heading "STATE OF PERAK", by deleting items 28 and 29.
