PADA menjalankan kuasa yang diberikan oleh seksyen 72 Akta Keselamatan Sosial Pekerja 1969 [*Akta 4*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Perbekalan Tambahan) (2016) 2017**.

(2) Peraturan-Peraturan ini disifatkan telah mula berkuat kuasa pada 1 Januari 2016.

Pengeluaran tambahan bagi perbelanjaan bagi tahun 2016

2. Suatu jumlah wang yang tidak melebihi lima puluh enam juta enam ratus ribu ringgit (RM56,600,000) hendaklah dikeluarkan daripada Kumpulan Wang Keselamatan Sosial bagi perbelanjaan tambahan untuk pentadbiran Rancangan Keselamatan Sosial sebagaimana yang diperuntukkan dalam Jadual bagi tahun 2016 yang tidak diperuntukkan atau yang tidak diperuntukkan dengan sepenuhnya di bawah Peraturan-Peraturan Keselamatan Sosial Pekerja (Perbekalan) 2016 [*P.U. (A) 51/2016*].

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (SUPPLEMENTARY SUPPLY) (2016)
REGULATIONS 2017

IN exercise of the powers conferred by section 72 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Employees' Social Security (Supplementary Supply) (2016) Regulations 2017**.

(2) These Regulations are deemed to have come into operation on 1 January 2016.

Additional issue for expenditure for the year 2016

2. A sum not exceeding fifty-six million six hundred thousand ringgit (RM56,600,000) shall be issued out of the Social Security Fund for additional expenditure on the administration of the Scheme of Social Security as specified in the Schedule for the year 2016 which is not provided for or not fully provided for under the Employees' Social Security (Supply) Regulations 2016 [P.U. (A) 51/2016].
