AKTA KESELAMATAN SOSIAL PEKERJA 1969

PERATURAN-PERATURAN KESELAMATAN SOSIAL PEKERJA (PERBEKALAN) 2017

PADA menjalankan kuasa yang diberikan oleh seksyen 72 Akta Keselamatan Sosial Pekerja 1969 [*Akta 4*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Perbekalan) 2017**.

(2) Peraturan-Peraturan ini disifatkan telah mula berkuat kuasa pada 1 Januari 2017.

Pengeluaran bagi perbelanjaan bagi tahun 2017

2. Suatu jumlah wang yang tidak melebihi tujuh ratus tujuh puluh dua juta satu ratus empat puluh empat ribu ringgit (RM772,144,000) hendaklah dikeluarkan daripada Kumpulan Wang Keselamatan Sosial bagi perbelanjaan untuk pentadbiran Rancangan Keselamatan Sosial bagi tahun 2017 sebagaimana yang diperuntukkan dalam Jadual.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (SUPPLY) REGULATIONS 2017

IN exercise of the powers conferred by section 72 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Employees' Social Security (Supply) Regulations 2017**.

(2) These Regulations are deemed to have come into operation on 1 January 2017.

Issue for expenditure for the year 2017

2. A sum not exceeding seven hundred and seventy-two million one hundred and forty-four thousand ringgit (RM772,144,000) shall be issued out of the Social Security Fund for expenditure on the administration of the Scheme of Social Security for the year 2017 as provided in the Schedule.
