PERINTAH KAWALAN HARGA DAN ANTIPENCATUTAN (PENENTUAN HARGA RUNCIT

PADA menjalankan kuasa yang diberikan oleh seksyen 4 Akta Kawalan Harga dan Antipencatutan 2011 [*Akta 723*], Pengawal, dengan kelulusan Menteri, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Harga dan Antipencatutan (Penentuan Harga Runcit Maksimum bagi Petrol dan Diesel) (No. 28) 2017**.

(2) Perintah ini mula berkuat kuasa pada 12 Oktober 2017.

2. Harga runcit maksimum bagi petrol dan diesel hendaklah sebagaimana yang dinyatakan dalam Jadual.

PRICE CONTROL AND ANTI-PROFITEERING
(DETERMINATION OF MAXIMUM RETAIL PRICE FOR PETROL AND DIESEL)
(NO. 28) ORDER 2017

IN exercise of the powers conferred by section 4 of the Price Control and Anti-Profiteering Act 2011 [*Act 723*], the Controller, with the approval of the Minister, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Price Control and Anti-Profiteering (Determination of Maximum Retail Price for Petrol and Diesel) (No. 28) Order 2017**.

(2) This Order comes into operation on 12 October 2017.

Maximum retail price for petrol and diesel

2. The maximum retail price for petrol and diesel shall be as specified in the Schedule.

Revocation

3. The Price Control and Anti-Profiteering (Determination of Maximum Retail Price for Petrol and Diesel) (No. 27) Order 2017 [*P.U. (A) 300/2017*] published in the *Gazette* on 4 October 2017 is revoked.
