AKTA PASARAN MODAL DAN PERKHIDMATAN 2007

PERATURAN-PERATURAN PASARAN MODAL DAN PERKHIDMATAN
(FI) (PINDAAN) 2017

PADA menjalankan kuasa yang diberikan oleh perenggan 378(2)(b) Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-Peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Fi) (Pindaan) 2017**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 10 Oktober 2017.

Pindaan peraturan 9

2. Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Fi) 2012 [*P.U. (A) 483/2012*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda —

(a) dalam nota bahu, dengan memasukkan selepas perkataan “melibatkan” perkataan “penilaian pakar dan”; dan

(b) dengan menggantikan perkataan “cadangan yang melibatkan” dengan perkataan “cadangan yang disebut dalam seksyen 212 Akta yang melibatkan penilaian pakar dan”.

3. Jadual 1 kepada Peraturan-Peraturan ibu dipinda dengan memasukkan selepas perkataan “kajian semula” di mana-mana jua terdapat perkataan “ penilaian pakar dan”.

4. Jadual 5 kepada Peraturan-Peraturan ibu dipinda dengan memasukkan selepas perkataan “kajian semula” di mana-mana jua terdapat perkataan “penilaian pakar dan”.

- (a) dalam tajuk, dengan memasukkan selepas perkataan “BERKENAAN DENGAN” perkataan “KAJIAN SEMULA PENILAIAN PAKAR DAN”; dan
- (b) dengan memasukkan selepas butiran 1 dan butir-butir yang berhubungan dengannya butiran yang berikut:

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES (FEES) (AMENDMENT) REGULATIONS 2017

IN exercise of the powers conferred by section 378(2)(b) of the Capital Markets and Services Act 2007 [Act 671], the Commission with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Capital Markets and Services (Fees) (Amendment) Regulations 2017**.

(2) These Regulations come into operation on 10 October 2017.

Amendment of regulation 9

2. The Capital Markets and Services (Fees) Regulations 2012 [P.U. (A) 483/2012], which is referred to as the “principal Order” in this Order, are amended —

(a) in the shoulder note, by inserting after the word “involving” the words “assessment by experts and”; and

(b) by substituting for the words “proposal involving” the words “proposal referred to in section 212 of the Act involving assessment by experts and”.

Amendment of Schedule 1

3. Schedule 1 to the principal Regulations is amended by inserting after the words “review of” wherever appearing the words “assessment by experts and”.

Amendment of Schedule 5

4. Schedule 5 to the principal Regulations is amended by inserting after the words “review of” wherever appearing the words “assessment by experts and”.

Amendment of Schedule 8

5. Schedule 8 to the principal Regulations is amended—

- (a) in the title, by inserting after the words “IN RESPECT OF” the words “REVIEW OF ASSESSMENT BY EXPERTS AND”; and
- (b) by inserting after item 1 and the particulars relating to it the following item:

6. Schedule 10 to the principal Regulations is amended by inserting after the words “review of” wherever appearing the words “assessment by experts and”.
