MALAY RESERVATIONS ENACTMENT

MALAY RESERVATIONS (FEDERAL TERRITORY)  
(AMENDMENT OF SECOND SCHEDULE) ORDER 2017

IN exercise of the powers conferred by subsection 17(2) of the Malay Reservations Enactment [*F.M.S. Cap. 142*], as modified by the Federal Territory (Modification of Malay Reservations Enactment) Order 1974 [*P.U. (A) 60/1974*] and the Federal Territory (Modification of Malay Reservations Enactment) (Amendment) Order 1984 [*P.U. (A) 340/1984*], the Yang di-Pertuan Agong makes the following order:

**Citation and application**

1. (1) This order may be cited as the **Malay Reservations (Federal Territory) (Amendment of Second Schedule) Order 2017**.

(2) This Order shall apply to the Federal Territory of Kuala Lumpur.

**Amendment of Second Schedule**

2. The Second Schedule to the Malay Reservations Enactment is amended by adding the following:
