PERINTAH KAWALAN HARGA DAN ANTIPENCATUTAN (PENENTUAN HARGA RUNCIT  
MAKSIMUM BAGI PETROL DAN DIESEL) (NO. 20) 2017

PADA menjalankan kuasa yang diberikan oleh seksyen 4 Akta Kawalan Harga dan Antipencatutan 2011 [*Akta 723*], Pengawal, dengan kelulusan Menteri, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Harga dan Antipencatutan (Penentuan Harga Runcit Maksimum bagi Petrol dan Diesel) (No. 20) 2017**.

(2) Perintah ini mula berkuat kuasa pada 17 Ogos 2017.

**Harga runcit maksimum bagi petrol dan diesel**

2. Harga runcit maksimum bagi petrol dan diesel hendaklah sebagaimana yang dinyatakan dalam Jadual.

PRICE CONTROL AND ANTI-PROFITEERING  
(DETERMINATION OF MAXIMUM RETAIL PRICE FOR PETROL AND DIESEL)  
(NO. 20) ORDER 2017

IN exercise of the powers conferred by section 4 of the Price Control and Anti-Profiteering Act 2011 [*Act 723*], the Controller, with the approval of the Minister, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Price Control and Anti-Profiteering (Determination of Maximum Retail Price for Petrol and Diesel) (No. 20) Order 2017**.

(2) This Order comes into operation on 17 August 2017.

**Maximum retail price for petrol and diesel**

2. The maximum retail price for petrol and diesel shall be as specified in the Schedule.

**Revocation**

3. The Price Control and Anti-Profiteering (Determination of Maximum Retail Price for Petrol and Diesel) (No. 19) Order 2017 [*P.U. (A) 230/2017*] published in the *Gazette* on 9 August 2017 is revoked.
