AKTA LEMBAGA PELESENAN KENDERAAN PERDAGANGAN 1987

KAEDAH-KAEDAH KENDERAAN MOTOR
(PENGANGKUTAN PERDAGANGAN) (PINDAAN) 2017

PADA menjalankan kuasa yang diberikan oleh perenggan 56(1)(d) dan (h) Akta Lembaga Pelesenan Kenderaan Perdagangan 1987 [Akta 334], Menteri membuat kaedah-kaedah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Kenderaan Motor (Pengangkutan Perdagangan) (Pindaan) 2017**.

(2) Kaedah-Kaedah ini mula berkuat kuasa pada 1 Ogos 2017.

Kaedah baharu 10A

2. Kaedah-Kaedah Kenderaan Motor (Pengangkutan Perdagangan) 1959 [L.N. 175/1959], yang disebut “Kaedah-Kaedah ibu” dalam Kaedah-Kaedah ini, dipinda dengan memasukkan selepas kaedah 10 kaedah yang berikut:

“Driver’s card 10A. (1) When a licence has been granted in respect of a public service vehicle to operate within Sabah, the licence holder shall apply for every driver of the vehicle a driver’s card.

(2) The driver shall carry the driver’s card at all times during which the driver is driving the public service vehicle.

(3) The fee to be charged for a driver’s card shall be as specified in item 5G of the Fifth Schedule.”.

Pindaan Jadual Kelima

3. Jadual Kelima kepada Kaedah-Kaedah ibu dipinda di bawah kepala “PART II—SABAH”—

(a) dalam butiran 1A, di bawah ruang “*Amount of Fee*”, dengan menggantikan perkataan “10 00” di mana-mana jua terdapat dengan perkataan “20 00”;

(b) dengan menggantikan butiran 5 dengan butiran yang berikut:

“5. For supplying—

(a) a duplicate license for license 300 00
that is lost

(b) a duplicate license for license 20 00”;
that is destroyed, defaced or the
particulars thereof have
become illegible

(c) dalam butiran 5A, di bawah ruang “*Amount of Fee*”, dengan menggantikan perkataan “20 00” dengan perkataan “30 00”;

(d) dalam butiran 5B—

(i) dalam subbutiran (a), (c), (d), (e), (g), (h) dan (j), di bawah ruang “*Amount of Fee*”, dengan menggantikan perkataan “20 00” dengan perkataan “30 00”; dan

(ii) dalam subbutiran (f), (i) dan (k), di bawah ruang “*Amount of Fee*”, dengan menggantikan perkataan “10 00” dengan perkataan “30 00”;

(e) dalam butiran 5C, di bawah ruang “*Amount of Fee*”, dengan menggantikan perkataan “50 00” dengan perkataan “100 00”;

- (f) dalam butiran 5D, di bawah ruang “*Amount of Fee*”, dengan menggantikan perkataan “50 00” dengan perkataan “100 00”;
- (g) dalam butiran 5F, di bawah ruang “*Amount of Fee*”, dengan menggantikan perkataan “15 00” dengan perkataan “30 00”; dan
- (h) dengan memasukkan selepas butiran 5F butiran yang berikut:

“5G.	For each driver’s card issued to driver of a public service vehicle	30 00 per annum or part thereof”.

COMMERCIAL VEHICLES LICENSING BOARD ACT 1987

MOTOR VEHICLES (COMMERCIAL TRANSPORT) (AMENDMENT) RULES 2017

IN exercise of the powers conferred by paragraphs 56(1)(d) and (h) of the Commercial Vehicles Licensing Board Act 1987 [Act 334], the Minister makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Motor Vehicles (Commercial Transport) (Amendment) Rules 2017**.

(2) These Rules come into operation on 1 August 2017.

New rule 10A

2. The Motor Vehicles (Commercial Transport) Rules 1959 [L.N. 175/1959], which are referred to as “the principal Rules” in these Rules, are amended by inserting after rule 10 the following rule:

“Driver’s card 10A. (1) When a licence has been granted in respect of a public service vehicle to operate within Sabah, the licence holder shall apply for every driver of the vehicle a driver’s card.

(2) The driver shall carry the driver’s card at all times during which the driver is driving the public service vehicle.

(3) The fee to be charged for a driver’s card shall be as specified in item 5G of the Fifth Schedule.”.

Amendment of Fifth Schedule

3. The Fifth Schedule to the principal Rules is amended under the heading “PART II—SABAH”—

(a) in item 1A, under the column “*Amount of Fee*”, by substituting for the word “10 00” wherever appearing the word “20 00”;

(b) by substituting for item 5 the following item:

“5. For supplying—

(a) a duplicate license for 300 00
license that is lost

(b) a duplicate license for 20 00”;
license that is destroyed,
defaced or the particulars
thereof have become
illegible

(c) in item 5A, under the column “*Amount of Fee*”, by substituting for the word “20 00” the word “30 00”;

(d) in item 5B—

(i) in subitems (a), (c), (d), (e), (g), (h) and (j), under the column “*Amount of Fee*”, by substituting for the word “20 00” the word “30 00”; and

(ii) in subitems (f), (i) and (k), under the column “*Amount of Fee*”, by substituting for the word “10 00” the word “30 00”;

(e) in item 5C, under the column “*Amount of Fee*”, by substituting for the word “50 00” the word “100 00”;

- (f) in item 5D, under the column “*Amount of Fee*”, by substituting for the word “50 00” the word “100 00”;
- (g) in item 5F, under the column “*Amount of Fee*”, by substituting for the word “15 00” the word “30 00”; and
- (h) by inserting after item 5F the following item:

“5G.	For each driver’s card issued to	30 00 per
	driver of a public service vehicle	annum or
		part thereof”.
