AKTA PELINDUNG 2006 DAN AKTA KASTAM 1967

PERINTAH KASTAM (DUTI PELINDUNG MukTAMAD) (PINDAAN) 2017

PADA menjalankan kuasa yang diberikan oleh subseksyen 23(3) Akta Pelindung 2006 [*Akta 657*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Pelindung Muktamad) (Pindaan) 2017**.

(2) Perintah ini disifatkan telah berkuat kuasa bagi tempoh mulai 14 April 2017 hingga 13 April 2020.

SAFEGUARDS ACT 2006 AND CUSTOMS ACT 1967

CUSTOMS (DEFINITIVE SAFEGUARDS DUTIES) (AMENDMENT) ORDER 2017

IN exercise of the powers conferred by subsection 23(3) of the Safeguards Act 2006 [Act 657] and subsection 11(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Definitive Safeguards Duties) (Amendment) Order 2017**.

(2) This Order is deemed to have effect for the period from 14 April 2017 until 13 April 2020.

Amendment of Schedule

2. Customs (Definitive Safeguards Duties) Order 2017 [P.U. (A) 122/2017] is amended in the Schedule—

(a) by substituting for subheading “7214.30.00 10” subheading “7214.30.10 00”; and

(b) by substituting for subheading “7214.30.00 90” subheading “7214.30.90 00”.
