AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) (NO. 4) 2017

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) (Pindaan) (No. 4) 2017**.

(2) Perintah ini mula berkuat kuasa pada 25 Mei 2017.

(xxv) Coastal Energy Malaysia Sdn. Bhd.”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 4) ORDER 2017

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 4) Order 2017**.

(2) This Order comes into operation on 25 May 2017.

**Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2013 [*P.U. (A) 371/2013*] is amended in Part I of the Schedule, in relation to item 66, in column (2), by inserting after paragraph (xxiii) the following paragraphs:

“(xxiv) Ophir Production Sdn. Bhd.

(xxv) Coastal Energy Malaysia Sdn. Bhd.”.
