FISHERIES (APPOINTMENT OF AUTHORIZED OFFICER) ORDER 2017

IN exercise of the powers conferred by section 36 of the Fisheries Act 1985 [*Act 317*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Fisheries (Appointment of Authorized Officer) Order 2017**.

**Appointment of authorized officers**

2. The Minister appoints the Johor National Park Corporation personnel specified in the Schedule as authorized officers for the purposes of the Act.
