FINANCIAL SERVICES ACT 2013

FINANCIAL SERVICES (INSURANCE (EXEMPTION) ORDER 2009) (EXEMPTION)  
(AMENDMENT) ORDER 2017

IN exercise of the powers conferred by section 263 of the Financial Services Act 2013 [*Act 758*], the Minister, on the recommendation of the Bank, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Financial Services (Insurance (Exemption) Order 2009) (Exemption) (Amendment) Order 2017**.

(2) This Order comes into operation on 7 April 2017.

**Deletion of paragraphs 4, 5 and 6**

2. The Insurance (Exemption) Order 2009 [*P.U. (A) 136/2009*] is amended by deleting paragraphs 4, 5 and 6.
