LOANS GUARANTEE (BODIES CORPORATE) ACT 1965

LOANS GUARANTEE (DECLARATION OF BODIES CORPORATE)  
(PERUMAHAN RAKYAT 1MALAYSIA CORPORATION) ORDER 2017

IN exercise of the powers conferred by section 3 of the Loans Guarantee (Bodies Corporate) Act 1965 [Act 96], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Loans Guarantee (Declaration of Bodies Corporate) (Perumahan Rakyat 1Malaysia Corporation) Order 2017**.

(2) This Order comes into operation on 1 April 2017.

**Declaration of application of the Act**

2. The body corporate known as the Perumahan Rakyat 1Malaysia Corporation is declared to be a body corporate to which the Act applies.
