MINIMUM RETIREMENT AGE ACT 2012

MINIMUM RETIREMENT AGE (EXEMPTION) (NO. 4) ORDER 2017

IN exercise of the powers conferred by section 18 of the Minimum Retirement Age Act 2012 [Act 753], the Minister makes the following order:

Citation

1. This order may be cited as the **Minimum Retirement Age (Exemption) (No. 4) Order 2017**.

Exemption

2. The Minister exempts Halal Industry Development Corporation Sdn. Bhd. with the registration number 747683-X from all provisions of the Act in respect of its employee, namely Dato' Seri Jamil bin Bidin, who is employed on a fixed term contract of service, inclusive of any extension, of more than sixty months for the position of Chief Executive Officer.
