PADA menjalankan kuasa yang diberikan oleh subseksyen 153(3) Akta Pendidikan 1996 [*Akta 550*] yang dibaca bersama dengan Bahagian VIII Akta Yayasan Guru Tun Hussein Onn 2014 [*Akta 763*], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pendidikan (Kaedah-Kaedah Kumpulan Wang Simpanan Guru 1962) (Pembatalan) 2017**.

**Pembubaran Lembaga**

3. Lembaga Kumpulan Wang Simpanan Guru yang ditubuhkan di bawah Kaedah-Kaedah Kumpulan Wang Simpanan Guru 1962 dibubarkan.

EDUCATION ACT 1996

EDUCATION (TEACHERS PROVIDENT FUND RULES 1962)  
(REVOCATION) REGULATIONS 2017

IN exercise of the powers conferred by subsection 153(3) of the Education Act 1996 [Act 550] read together with Part VIII of the Yayasan Guru Tun Hussein Onn Act 2014 [Act 763], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Education (Teachers Provident Fund Rules 1962) (Revocation) Regulations 2017**.

(2) These Regulations come into operation on 16 January 2017.

**Revocation**

2. The Teachers Provident Fund Rules 1962 [L.N 29/1962] are revoked.

**Dissolution of Board**

3. The Teachers Provident Fund Board established under the Teachers Provident Fund Rules 1962 is dissolved.
