AKTA SENJATA 1960

PERATURAN-PERATURAN SENJATA (PINDAAN JADUAL KEDUA) 2016

PADA menjalankan kuasa yang diberikan oleh seksyen 59 Akta Senjata 1960 [*Akta 206*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Senjata (Pindaan Jadual Kedua) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2017.

Pindaan Jadual Kedua

2. Jadual Kedua kepada Akta Senjata 1960 dipinda dengan memasukkan selepas butiran 17 dan butir-butir yang berhubungan dengannya butiran dan butir-butir yang berikut:

ARMS ACT 1960

ARMS (AMENDMENT OF SECOND SCHEDULE) REGULATIONS 2016

IN exercise of the powers conferred by section 59 of the Arms Act 1960 [*Act 206*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Arms (Amendment of Second Schedule) Regulations 2016**.

(2) These Regulations come into operation on 1 January 2017.

Amendment of Second Schedule

2. The Second Schedule to the Arms Act 1960 is amended by inserting after item 17 and the particulars relating to it the following item and particulars:

<i>(a)</i>	For an arms card under regulation 6A	RM 30.00

<i>(i)</i>	for the first loss	RM 50.00
<i>(ii)</i>	for the second loss	RM 100.00
<i>(iii)</i>	for the third and following loss	RM1000.00”.
