CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 6) ORDER 2016

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [Act 122], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Control of Supplies (Controlled Articles) (No. 6) Order 2016**.

**Controlled articles**

2. The articles specified in the Schedule are declared to be controlled articles for the period from 19 December 2016 to 28 December 2016.
