1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Utara Selatan Hubungan Tengah dan Lebuh Raya KLIA) (Pindaan) (No. 3) 2016**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2017.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(NORTH SOUTH EXPRESSWAY CENTRAL LINK AND KLIA EXPRESSWAY)
(AMENDMENT) (NO. 3) ORDER 2016

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This Order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (North South Expressway Central Link and KLIA Expressway) (Amendment) (No. 3) Order 2016**.

(2) This Order comes into operation on 1 January 2017.

General amendment

2. The Federal Roads (Private Management) (Collection of Tolls) (North South Expressway Central Link and KLIA Expressway) Order 2002 [*P.U. (A) 437/2002*] is amended by substituting for the words “31 DECEMBER 2016” and “31 December 2016” wherever appearing the words “31 DECEMBER 2017” and “31 December 2017” respectively.
