1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) [Lebuhraya Jitra-Sungai Dua (Butterworth)] (Pindaan) (No. 2) 2016**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2017.

ORDER 2016

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) [Jitra-Sungai Dua (Butterworth) Expressway] (Amendment) (No. 2) Order 2016**.

(2) This Order comes into operation on 1 January 2017.

**Amendment of First Schedule and First Schedule—A**

2. The Federal Roads (Private Management) (Collection of Tolls) [Jitra-Sungai Dua (Butterworth) Expressway] Order 1993 [*P. U. (A) 229/1993*] is amended in the First Schedule and First Schedule—A in the heading by substituting for the words “31 DECEMBER 2016” the words “31 DECEMBER 2017”.
