(2) Perintah ini mula berkuat kuasa pada 1 Januari 2017.

(AMENDMENT) (NO. 3) ORDER 2016

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This Order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Juru-Jalan Duta-Bukit Raja Expressway, North South Expressway Central Link and Kuala Lumpur-Johore Bahru Expressway) (Amendment) (No. 3) Order 2016.**

(2) This Order comes into operation on 1 January 2017.

General amendment

2. The Federal Roads (Private Management) (Collection of Tolls) (Juru-Jalan Duta-Bukit Raja Expressway, North South Expressway Central Link and Kuala Lumpur-Johore Bahru Expressway) Order 2002 [*P. U. (A) 171/2002*] is amended by substituting for the words “31 DECEMBER 2016” and “31 December 2016” wherever appearing the words “31 DECEMBER 2017” and “31 December 2017” respectively.
