(2) Perintah ini mula berkuat kuasa pada 1 Januari 2017.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(BUKIT KAYU HITAM-JITRA HIGHWAY) (AMENDMENT) (NO. 2) ORDER 2016

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Bukit Kayu Hitam-Jitra Highway) (Amendment) (No. 2) Order 2016**.

(2) This Order comes into operation on 1 January 2017.

Amendment of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Bukit Kayu Hitam-Jitra Highway) Order 1989 [*P.U. (A) 16/1989*] is amended in the First Schedule in the heading by substituting for the words “31 DECEMBER 2016” the words “31 DECEMBER 2017”.
