AKTA KASTAM 1967

PERINTAH KASTAM (LARANGAN MENGENAI EKSPORT) (PINDAAN) (NO. 3) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Eksport) (Pindaan) (No. 3) 2016**.

(2) Perintah ini mula berkuat kuasa pada 1 Oktober 2016.

Pindaan Jadual Pertama

2. Perintah Kastam (Larangan Mengenai Eksport) 2012 [*P.U. (A) 491/2012*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama dengan memotong butiran 2 dan butir-butir yang berhubungan dengannya.

Pindaan Jadual Kedua

3. Perintah ibu dipinda dalam Jadual Kedua—

(a) berhubung dengan butiran 7, dengan menggantikan subbutiran (1) dalam ruang (2) di bawah kepala “*Description of Goods*” dan butir-butir yang berhubungan dengannya dalam ruang (3) di bawah kepala “*Chapter/Heading/Subheading*”, dengan butir-butir yang berikut:

(2) <i>Description of Goods</i>	(3) <i>Chapter/Heading/Subheading</i>
“(1) Minerals (excluding salt, iron pyrites, sulphur, natural graphite, quartz, cement and natural borates)	Chapter 25 (excluding 2501.00 000 - 25.04, 25.06, 25.23 and 25.28)”; dan

- (b) berhubung dengan butiran 8, dengan menggantikan butir-butir dalam ruang (2) di bawah kepala "*Description of Goods*" dan butir-butir dalam ruang (3) di bawah kepala "*Chapter/Heading/Subheading*", dengan butir-butir yang berikut:

(2) <i>Description of Goods</i>	(3) <i>Chapter/Heading/Subheading</i>
"All kinds of natural sands	25.05".

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF EXPORTS) (AMENDMENT) (NO. 3) ORDER 2016

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Exports) (Amendment) (No. 3) Order 2016**.

(2) This Order comes into operation on 1 October 2016.

Amendment of First Schedule

2. The Customs (Prohibition of Exports) Order 2012 [*P.U. (A) 491/2012*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule by deleting item 2 and the particulars relating to it.

Amendment of Second Schedule

3. The principal Order is amended in the Second Schedule—

(a) in relation to item 7, by substituting for subitem (1) in column (2) under the heading “*Description of Goods*” and the particulars relating to it in column (3) under the heading “*Chapter/Heading/Subheading*”, the following particulars:

(2) <i>Description of Goods</i>	(3) <i>Chapter/Heading/Subheading</i>
“(1) Minerals (excluding salt, iron pyrites, sulphur, natural graphite, quartz, cement and natural borates)	Chapter 25 (excluding 2501.00 000 - 25.04, 25.06, 25.23 and 25.28)”; and

- (b) in relation to item 8, by substituting for the particulars in column (2) under the heading "*Description of Goods*" and the particulars in column (3) under the heading "*Chapter/Heading/Subheading*", the following particulars:

(2) <i>Description of Goods</i>	(3) <i>Chapter/Heading/Subheading</i>
"All kinds of natural sands	25.05".
