PERATURAN-PERATURAN PASARAN MODAL DAN PERKHIDMATAN (DANA PAMPASAN PASARAN MODAL) (CARUMAN) (PINDAAN) 2016

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES (CAPITAL MARKET COMPENSATION FUND)
(CONTRIBUTION) (AMENDMENT) REGULATIONS 2016

IN exercise of the powers conferred by subsection 160(1) of the Capital Markets and Services Act 2007 [Act 671], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Capital Markets and Services (Capital Market Compensation Fund) (Contribution) (Amendment) Regulations 2016**.

(2) These Regulations come into operation on 7 September 2016.

Amendment of Schedule 1

2. The Capital Markets and Services (Capital Market Compensation Fund) (Contribution) Regulations 2012 [P.U. (A) 482/2012] are amended in Part 1 of Schedule 1 by inserting after item "Trading participant or a holder of a Capital Markets Services Licence for fund management, trading in derivatives in Specified Exchange" and the particulars relating to it the following item and particulars:
