PERATURAN-PERATURAN KASTAM (FI LESEN IMPORT KENDERAAN BERMOTOR)
(PINDAAN) (NO. 2) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 142(15) Akta Kastam 1967 [*Akta 235*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Fi Lesen Import Kenderaan Bermotor) (Pindaan) (No. 2) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 25 Ogos 2016.

CUSTOMS ACT 1967

CUSTOMS (IMPORT LICENCE FEE FOR MOTOR VEHICLE) (AMENDMENT) (NO. 2)
REGULATIONS 2016

IN exercise of the powers conferred by subsection 142(15) of the Customs Act 1967 [*Act 235*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Import Licence Fee for Motor Vehicle) (Amendment) (No. 2) Regulations 2016**.

(2) These Regulations come into operation on 25 August 2016.

Amendment of Schedule

2. The Customs (Import Licence Fee for Motor Vehicle) Regulations 2009 [*P.U. (A) 491/2009*] are amended in the Schedule in relation to item 69 in column (2), by substituting for the words “Syarikat SRS Bumi Motors Sdn. Bhd.” the words “Kemas Maju Motors Sdn. Bhd.”.
