PADA menjalankan kuasa yang diberikan oleh subseksyen 26(2) Akta Pampasan Pekerja 1952 [*Akta 273*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) (Pindaan) 2016**.

(2) Subsubperenggan 2(*a*) disifatkan telah mula berkuat kuasa pada 15 Julai 2015.

(3) Subsubperenggan 2(*b*) disifatkan telah mula berkuat kuasa pada 5 Mei 2014.

(4) Subsubperenggan 2(*c*) disifatkan telah mula berkuat kuasa pada 22 April 2015.

Pindaan Jadual

2. Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) 2005 [*P.U. (A) 45/2005*] dipinda dalam Jadual—

(*a*) dengan menggantikan perkataan “Multi-Purpose Insurans Bhd.” dengan perkataan “MPI Generali Insurans Berhad”;

(*b*) dengan menggantikan perkataan “Takaful Ikhlas Sdn. Bhd.” dengan perkataan “Takaful Ikhlas Berhad”; dan

(*c*) dengan menggantikan perkataan “Uni. Asia General Insurance Berhad” dengan perkataan “Liberty Insurance Berhad”.

WORKMEN'S COMPENSATION ACT 1952

WORKMEN'S COMPENSATION (FOREIGN WORKERS' COMPENSATION SCHEME)
(INSURANCE) (AMENDMENT) ORDER 2016

IN exercise of the powers conferred by subsection 26(2) of the Workmen's Compensation Act 1952 [*Act 273*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) (Amendment) Order 2016**.

(2) Subsubparagraph 2(*a*) is deemed to have come into operation on 15 July 2015.

(3) Subsubparagraph 2(*b*) is deemed to have come into operation on 5 May 2014.

(4) Subsubparagraph 2(*c*) is deemed to have come into operation on 22 April 2015.

Amendment of Schedule

2. The Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) Order 2005 [*P.U. (A) 45/2005*] is amended in the Schedule—

(*a*) by substituting for the words "Multi-Purpose Insurans Bhd." the words "MPI Generali Insurans Berhad";

(*b*) by substituting for the words "Takaful Ikhlas Sdn. Bhd." the words "Takaful Ikhlas Berhad"; and

(c) by substituting for the words “Uni. Asia General Insurance Berhad” the words “Liberty Insurance Berhad”.
