AKTA PERTUBUHAN PELADANG 1973

PERATURAN-PERATURAN PERTUBUHAN PELADANG (PINDAAN) (NO. 2) 2016

PADA menjalankan kuasa yang diberikan oleh seksyen 35 Akta Pertubuhan Peladang 1973 [*Akta 109*], Lembaga Pertubuhan Peladang, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pertubuhan Peladang (Pindaan) (No.2) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 29 Januari 2016.

**Pindaan peraturan 35**

2. Peraturan-Peraturan Pertubuhan Peladang 1983 [*P.U. (A) 303/1983*], yang disebut "Peraturan-Peraturan ibu" dalam Peraturan-Peraturan ini, dipinda dalam perenggan 35(1)(c) dengan menggantikan perkataan "empat" dengan perkataan "enam".

**Penerusan pemegangan jawatan**

3. (1) Walau apa pun perenggan 3(a) Peraturan-Peraturan Pertubuhan Peladang (Pindaan) 2016 [*P.U. (A) 17/2016*], ahli Jemaah Pengarah yang dilantik oleh Menteri di bawah perenggan 35(3)(c) Peraturan-Peraturan ibu pada 28 Januari 2016 sebaik sebelum permulaan kuat kuasa Peraturan-Peraturan Pertubuhan Peladang (Pindaan) 2016 hendaklah, apabila Peraturan-Peraturan ini mula berkuat kuasa, disifatkan telah dilantik dengan sewajarnya dan terus memegang jawatan sehingga tamat tempoh yang ditentukan oleh Menteri bagi pelantikan itu.

(2) Apa-apa perbuatan yang dilakukan, tindakan yang diambil atau keputusan yang dibuat oleh ahli Jemaah Pengarah yang disebut dalam subperaturan (1) hendaklah disifatkan sah dan boleh diteruskan dengan sewajarnya oleh ahli Jemaah Pengarah.

FARMERS' ORGANIZATION ACT 1973

FARMERS' ORGANIZATION (AMENDMENT) (NO. 2) REGULATIONS 2016

IN exercise of the powers conferred by section 35 of the Farmers' Organization Act 1973 [*Act 109*], the Farmers' Organization Authority, with the approval of the Minister, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Farmers' Organization (Amendment) (No.2) Regulations 2016**.

(2) These Regulations come into operation on 29 January 2016.

**Amendment of regulation 35**

2. The Farmers' Organization Regulations 1983 [*P.U.(A) 303/1983*] which are referred to as the "principal Regulations" in these Regulations, is amended in paragraph 35(1)(c) by substituting for the word "four" the word "six".

**Continuance of service**

3. (1) Notwithstanding paragraph 3(a) of the Farmers' Organization (Amendment) Regulations 2016 [*P.U. (A) 17/2016*], the members of the Board of Directors appointed by the Minister under paragraph 35(3)(c) of the principal Regulations on 28 January 2016 immediately before the commencement of the Farmers' Organization (Amendment) Regulations 2016 shall, upon the commencement of these Regulations, be deemed to be duly appointed and continue to hold office until the end of the term determined by the Minister for the said appointment.

(2) Any act done, action taken or decision made by the members of the Board of Directors referred to in subregulation (1) shall be deemed to be valid and may accordingly be continued by the Board of Directors.
