PERATURAN-PERATURAN PASARAN MODAL DAN PERKHIDMATAN (FI)
(PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh perenggan 378(2)(b) Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Fi) (Pindaan) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 Ogos 2016.

Pindaan peraturan 2

2. Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Fi) 2012 [*P.U. (A) 483/2012*] yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam peraturan 2, dengan memotong takrif “Kod”.

Pindaan Jadual 2

3. Jadual 2 kepada Peraturan-Peraturan ibu dipinda berhubung dengan butiran 4, dalam ruang “Perihalan”, dengan menggantikan perkataan “peruntukan Kod” dengan perkataan “peruntukan pengambilalihan, percantuman atau pengambilan paksa”.

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES (FEES)
(AMENDMENT) REGULATIONS 2016

IN exercise of the powers conferred by paragraph 378(2)(b) of the Capital Markets and Services Act 2007 [Act 671], the Commission, with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Capital Markets and Services (Fees) (Amendment) Regulations 2016**.

(2) These Regulations come into operation on 15 August 2016.

Amendment of regulation 2

2. The Capital Markets and Services (Fees) Regulations 2012 [P.U. (A) 483/2012], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 2, by deleting the definition of “Code”.

Amendment of Schedule 2

3. Schedule 2 to the principal Regulations is amended in relation to item 4, in column “Description”, by substituting for the words “provisions of the Code” the words “take-over, merger or compulsory acquisition provisions”.
