AKTA SURUHANJAYA KOPERASI MALAYSIA 2007

PERINTAH SURUHANJAYA KOPERASI MALAYSIA (TARIKH PELETAKHAKAN) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 5(1) Akta Suruhanjaya Koperasi Malaysia 2007 [*Akta 665*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Suruhanjaya Koperasi Malaysia (Tarikh Peletakhakan) 2016**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 1 Januari 2008.

Tarikh peletakhakan

2. Menteri menetapkan 1 Januari 2008 sebagai tarikh peletakhakan bagi maksud seksyen 5 Akta dan pada tarikh itu segala harta, hak dan liabiliti—

(a) Kerajaan Malaysia;

(b) Ketua Pendaftar Koperasi bagi Malaysia di bawah Akta Koperasi 1993 [*Akta 502*];

(c) Pendaftar Persatuan Nelayan di bawah Akta Persatuan Nelayan 1971 [*Akta 44*]; dan

(d) Pendaftar Pertubuhan Peladang di bawah Akta Pertubuhan Peladang 1973 [*Akta 109*],

yang dinyatakan dalam Jadual hendaklah dipindahkan dan diletak hak pada Suruhanjaya Koperasi Malaysia tanpa apa-apa pemindahhakan, penyerahhakan atau pemindahan hakmilik.

MALAYSIA CO-OPERATIVE SOCIETIES COMMISSION ACT 2007

MALAYSIA CO-OPERATIVE SOCIETIES COMMISSION (VESTING DATE) ORDER 2016

IN exercise of the powers conferred by subsection 5(1) of the Malaysia Co-operative Societies Commission Act 2007 [*Act 665*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Malaysia Co-operative Societies Commission (Vesting Date) Order 2016**.

(2) This Order is deemed to have come into operation on 1 January 2008.

Vesting date

2. The Minister appoints 1 January 2008 as the vesting date for the purposes of section 5 of the Act and on such date all properties, rights and liabilities of—

(a) the Government of Malaysia;

(b) the Registrar General of Co-operative Societies for Malaysia under the Co-operative Societies Act 1993 [*Act 502*];

(c) the Registrar of Fishermen's Associations under the Fishermen's Associations Act 1971 [*Act 44*]; and

(d) the Registrar of Farmers' Organizations under the Farmers' Organization Act 1973 [*Act 109*],

specified in the Schedule shall be transferred to and be vested in the Malaysia Co-operative Societies Commission without any conveyance, assignment or transfer.
