HIGHWAY AUTHORITY MALAYSIA (INCORPORATION) (COLLECTION OF TOLLS)
(EAST COAST EXPRESSWAY-PHASE 2) (REVOCATION) ORDER 2016

IN exercise of the powers conferred by subsection 21A(6) of the Highway Authority Malaysia (Incorporation) Act 1980 [*Act 231*], the Minister, with the concurrence of the Minister of Finance, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Highway Authority Malaysia (Incorporation) (Collection of Tolls) (East Coast Expressway-Phase 2) (Revocation) Order 2016**.

(2) This Order comes into operation on 15 July 2016.
