COMMUNICATIONS AND MULTIMEDIA ACT 1998

COMMUNICATIONS AND MULTIMEDIA (RATES) (REVOCATION) RULES 2016

IN exercise of the powers conferred by subsection 201(1) of the Communications and Multimedia Act 1998 [Act 588], the Minister makes the following rules:

**Citation and commencement**

1. (1) These rules may be cited as the **Communications and Multimedia (Rates) (Revocation) Rules 2016**.

(2) These Rules come into operation on 1 July 2016.

**Revocation**

2. The Communications and Multimedia (Rates) Rules 2002 [P.U. (A) 79/2002] are revoked.
