KAEDAH-KAEDAH PENGANGKUTAN JALAN (FI DAN CAJ BAGI MENDIRIKAN STRUKTUR BAGI PAPAN IKLAN DI JALAN PERSEKUTUAN) (PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 85A(3) Akta Pengangkutan Jalan 1987 [Akta 333], Menteri membuat kaedah-kaedah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Pengangkutan Jalan (Fi dan Caj bagi Mendirikan Struktur bagi Papan Iklan di Jalan Persekutuan) (Pindaan) 2016**.

(2) Kaedah-Kaedah ini mula berkuat kuasa pada 1 Julai 2016.

2. Kaedah-Kaedah Pengangkutan Jalan (Fi dan Caj bagi Mendirikan Struktur bagi Papan Iklan di Jalan Persekutuan) 2010 [P.U. (A) 405/2010], yang disebut "Kaedah-Kaedah ibu" dalam Kaedah-Kaedah ini, dipinda dengan menggantikan perkataan "caj sewaan" di mana-mana jua terdapat dengan perkataan "caj pendudukan".

3. Perenggan 2 Kaedah-Kaedah ibu dipinda dengan memasukkan selepas subperenggan (2) subperenggan yang berikut:

"(3) Fi dan caj itu boleh diketepikan oleh Menteri bagi agensi Kerajaan yang mendirikan struktur papan iklan untuk tujuan bukan komersial."

ROAD TRANSPORT ACT 1987

ROAD TRANSPORT (FEE AND CHARGE FOR ERECTING STRUCTURES FOR BILLBOARD
ON FEDERAL ROAD) (AMENDMENT) RULES 2016

In exercise of the powers conferred by subsection 85A(3) of the Road Transport Act 1987 [Act 333], the Minister makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Road Transport (Fee and Charge for Erecting Structures for Billboard on Federal Road) (Amendment) Rules 2016**.

(2) These Rules come into operation on 1 July 2016.

General amendment

2. The Road Transport (Fee and Charge for Erecting Structures for Billboard on Federal Road) Rules 2010 [*P.U. (A) 405/2010*], which are referred to as the “principal Rules” in these Rules, are amended by substituting for the words “rental charge” wherever appearing the words “occupancy charge”.

Amendment of paragraph 2

3. Paragraph 2 of the principal Rules is amended by inserting after subparagraph (2) the following subparagraph:

“(3) The fee and charge may be waived by the Minister for the Government agency erecting structures for billboard for non-commercial purposes.”.
