PERINTAH PERBADANAN INSURANS DEPOSIT MALAYSIA (HAD INSURANS DEPOSIT)  
(PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 42(2) Akta Perbadanan Insurans Deposit Malaysia 2011 [*Akta 720*], Menteri, atas syor Perbadanan, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Perbadanan Insurans Deposit Malaysia (Had Insurans Deposit) (Pindaan) 2016**.

(2) Perintah ini berkuat kuasa pada 27 Jun 2016.

**Pindaan perenggan 2**

2. Perintah Perbadanan Insurans Deposit Malaysia (Had Insurans Deposit) 2011 [*P.U. (A) 26/2011*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam perenggan 2—

(a) dalam nota bahu, dengan menggantikan perkataan “**Amaun maksimum**” dengan perkataan “**Had maksimum**”; dan

(b) dengan menggantikan perkataan “amaun maksimum” dengan perkataan “had maksimum”.

**Pindaan perenggan 3**

3. Perintah ibu dipinda dalam perenggan 3—

(a) dalam nota bahu, dengan menggantikan perkataan “**Amaun maksimum**” dengan perkataan “**Had maksimum**”; dan

(b) dengan menggantikan perkataan “amaun maksimum” dengan perkataan “had maksimum”.

MALAYSIA DEPOSIT INSURANCE CORPORATION ACT 2011  
MALAYSIA DEPOSIT INSURANCE CORPORATION (DEPOSIT INSURANCE LIMIT)  
(AMENDMENT) ORDER 2016

IN exercise of the powers conferred by subsection 42(2) of the Malaysia Deposit Insurance Corporation Act 2011 [*Act 720*], the Minister, on the recommendation of the Corporation, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Malaysia Deposit Insurance Corporation (Deposit Insurance Limit) (Amendment) Order 2016**.

(2) This Order comes into operation on 27 June 2016.

**Amendment of paragraph 2**

2. The Malaysia Deposit Insurance Corporation (Deposit Insurance Limit) Order 2011 [*P.U. (A) 26/2011*], which is referred to as the “principal Order” in this Order, is amended in paragraph 2—

(a) in the shoulder note, by substituting for the words “**Maximum amount**” the words “**Maximum limit**”; and

(b) by substituting for the words “maximum amount” the words “maximum limit”.

**Amendment of paragraph 3**

3. The principal Order is amended in paragraph 3—

(a) in the shoulder note, by substituting for the words “**Maximum amount**” the words “**Maximum limit**”; and

(b) by substituting for the words “maximum amount” the words “maximum limit”.
