Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Pasport (Visa kepada
Pelancong daripada Republik Rakyat China) (Pengeccualian) (Pindaan) 2016**.

(2) Perintah ini mula berkuat kuasa pada 1 Jun 2016
hingga 31 Disember 2016.

2. Perintah Pasport (Visa kepada Pelancong daripada Republik Rakyat China)
(Pengeccualian) 2016 [*P. U. (A) 46/2016*] dipinda dalam subperenggan 2(c)-

(a) dengan memotong perkataan “atau” di hujung subsubperenggan (v); dan

(b) dengan memasukkan selepas subsubperenggan (vi) subsubperenggan
yang berikut:

“(vii) U14 Lapangan Terbang Melaka, Batu Berendam, Melaka; atau

(viii) U16 Lapangan Terbang Labuan, Wilayah Persekutuan;”.

PASSPORT ACT 1966

PASSPORTS (VISA TO TOURIST FROM THE PEOPLE'S REPUBLIC OF CHINA)
(EXEMPTION) (AMENDMENT) ORDER 2016

IN exercise of the powers conferred by section 4 of the Passport Act 1966 [*Act 150*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Passports (Visa to Tourist from the People's Republic of China) (Exemption) (Amendment) Order 2016**.

(2) This Order comes into operation on 1 June 2016 until 31 December 2016.

Amendment of paragraph 2

2. The Passports (Visa to Tourist from the People's Republic of China) (Exemption) Order 2016 [*P.U. (A) 46/2016*] is amended in subparagraph 2(c)–

(a) by deleting the word “or” at the end of subparagraph (v); and

(b) by inserting after subparagraph (vi) the following subparagraphs:

“(vii) U14 Melaka Airport, Batu Berendam, Melaka; or

(viii) U16 Labuan Airport, Federal Territory;”.
