PERINTAH JALAN-JALAN PERSEKUTUAN (PENGURUSAN PERSENDIRIAN)
(PUNGUTAN TOL) (LEBUH RAYA BUTTERWORTH-KULIM) (PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Butterworth-Kulim) (Pindaan) 2016**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 12 Januari 2012.

Pindaan perenggan 2

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Butterworth-Kulim) 1996 [*P.U. (A) 564/1996*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam perenggan 2—

(a) dalam subperenggan (1)—

(i) dengan menggantikan perkataan “Konsortium Lebuh Raya Butterworth-Kulim (KLBK) Sdn. Bhd.” dengan perkataan “Projek Lebuh Raya Usahasama Berhad”;

(ii) dengan menggantikan perkataan “1 Jun 2005 sehingga 27 Jun 2026” dengan perkataan “12 Januari 2012 sehingga 31 Disember 2038”; dan

(iii) dengan menggantikan perkataan “ruang (2) Bahagian I dan II” dengan perkataan “ruang (1)”;

(b) dalam subsubperenggan (1)(a), dengan menggantikan perkataan “ruang (2) Bahagian I Jadual Pertama mengikut tahun-tahun konsesi yang dinyatakan dalam ruang (1)” dengan perkataan “ruang (2) Jadual Pertama”; dan

(c) dalam subsubperenggan (1)(b), dengan menggantikan perkataan “ruang (2) Bahagian II Jadual Pertama mengikut tahun-tahun konsesi yang dinyatakan dalam ruang (1)” dengan perkataan “ruang (2) Jadual Pertama”.

Penggantian Jadual Pertama

3. Perintah ibu dipinda dengan menggantikan Jadual Pertama dengan Jadual yang berikut:

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(BUTTERWORTH-KULIM EXPRESSWAY) (AMENDMENT) ORDER 2016

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Butterworth-Kulim Expressway) (Amendment) Order 2016**.

(2) This Order is deemed to have come into operation on 12 January 2012.

Amendment of paragraph 2

2. The Federal Roads (Private Management) (Collection of Tolls) (Butterworth-Kulim Expressway) Order 1996 [*P.U. (A) 564/1996*], which is referred to as the “principal Order” in this Order, is amended in paragraph 2—

(a) In subparagraph (1)—

(i) by substituting for the words “Konsortium Lebu Raya Butterworth-Kulim (KLBK) Sdn. Bhd.” the words “Projek Lebu Raya Usahasama Berhad”;

(ii) by substituting for the words “1 June 2005 to 27 June 2026” the words “12 January 2012 to 31 December 2038”; and

(iii) by substituting for the words “column (2) of Part I and II” the words “column (1)”.

- (b) in subparagraph (1)(a), by substituting for the words “column (2) of Part I of the First Schedule according to the concession years as specified in column (1)” the words “column (2) of the First Schedule”; and
- (c) in subparagraph (1)(b), by substituting for the words “column (2) of Part II of the First Schedule according to the concession years as specified in column (1)” the words “column (2) of the First Schedule”.

Substitution of First Schedule

3. The principal Order is amended by substituting for the First Schedule the following Schedule:

“FIRST SCHEDULE

[Subparagraph 2(1)]

RATES OF TOLL FOR THE PERIOD FROM 12 JANUARY 2012 UNTIL 31 DECEMBER 2016

(1) <i>Classes of Vehicles</i>	(2) <i>Toll Payable (RM)</i>	
	<i>Kubang Semang Toll Plaza</i>	<i>Lunas Toll Plaza</i>
1. Vehicles with two axles and three or four wheels (excluding taxis and buses)	1.60	1.60
2. Vehicles with two axles and five or six wheels (excluding buses)	3.20	3.20
3. Vehicles with three axles or more (excluding buses)	4.80	4.80
4. Taxis	0.80	0.80
5. Buses	1.60	1.60

For the purpose of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be calculated as part of the axles and wheels of the vehicle.”
