AKTA KASTAM 1967

PERINTAH KASTAM (LARANGAN MENGENAI EKSPORT) (PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Eksport) (Pindaan) 2016**.

(2) Perintah ini mula berkuat kuasa pada 1 Jun 2016.

Pindaan Jadual Kedua

2. Perintah Kastam (Larangan Mengenai Eksport) 2012 [*P.U. (A) 491/2012*] dipinda dalam Jadual Kedua—

(a) berhubung dengan subbutiran 26(14) dalam ruang (3) di bawah kepala “*Chapter/Heading/Subheading*” dengan menggantikan perkataan “2903.77 630” dengan perkataan “2903.73 000”; dan

(b) dengan memasukkan selepas butiran 27 dan butir-butir yang berhubungan dengannya butiran yang berikut:

(1) <i>Item No.</i>	(2) <i>Description of Goods</i>	(3) <i>Chapter/ Heading/ Subheading</i>	(4) <i>Destination</i>	(5) <i>Ministry/Department/ Statutory Body Issuing Licence</i>

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF EXPORTS) (AMENDMENT) ORDER 2016

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Exports) (Amendment) Order 2016**.

(2) This Order comes into operation on 1 June 2016.

Amendment of Second Schedule

2. The Customs (Prohibition of Exports) Order 2012 [*P.U. (A) 491/2012*] is amended in the Second Schedule—

(a) in relation to subitem 26(14) in column (3) under the heading “*Chapter/Heading/Subheading*” by substituting for the word “2903.77 630” the word “2903.73 000”; and

(b) by inserting after item 27 and the particulars relating to it the following item:

(1) <i>Item No.</i>	(2) <i>Description of Goods</i>	(3) <i>Chapter/ Heading/ Subheading</i>	(4) <i>Destination</i>	(5) <i>Ministry/Department/ Statutory Body Issuing Licence</i>
“28.	Alpha-Phenylacetoacetonitrile (APAAN)	2926.90 000	All countries	Pharmaceutical Services Division, Ministry of Health”.
