LABUAN BUSINESS ACITIVITY TAX (FORMS) (REVOCATION) REGULATIONS 2016

IN exercise of the powers conferred by section 21 of the Labuan Business Activity Tax Act 1990 [*Act 445*], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Labuan Business Activity Tax (Forms) (Revocation) Regulations 2016**.

2. The Labuan Business Activity Tax (Forms) Regulations 2013 [*P.U. (A) 224/2013*] are revoked.
