AKTA PASARAN MODAL DAN PERKHIDMATAN 2007

PERATURAN-PERATURAN PASARAN MODAL DAN PERKHIDMATAN  
(PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 378(1) Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Pindaan) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 27 April 2016.

**Pindaan peraturan 8**

2. Peraturan-Peraturan Pasaran Modal dan Perkhidmatan 2012 [*P.U. (A) 474/2012*] yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dengan menggantikan perenggan 8(1)(c) dengan perenggan yang berikut:

“(c) suatu permohonan pendaftaran sebagai pengendali pasaran diiktiraf di bawah subseksyen 34(1) Akta;”.

**Pindaan Jadual 2**

3. Bahagian I Jadual 2 kepada Peraturan-Peraturan ibu dipinda—

(a) dengan menggantikan perkataan “kemudahan elektronik” dengan perkataan “pengendali pasaran diiktiraf”; dan

(b) dengan menggantikan butiran “Pendaftaran kemudahan elektronik di bawah subseksyen 34(1) Akta” dan butir-butir yang berhubungan dengannya dengan butiran dan butir-butir yang berikut:

“

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES  
(AMENDMENT) REGULATIONS 2016

IN exercise of the powers conferred by subsection 378(1) of the Capital Markets and Services Act 2007 [*Act 671*], the Commission, with the approval of the Minister, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Capital Markets and Services (Amendment) Regulations 2016**.

(2) These Regulations come into operation on 27 April 2016.

**Amendment of regulation 8**

2. The Capital Markets and Services Regulations 2012 [*P.U. (A) 474/2012*], which is referred to as the “principal Regulations” in these Regulations, are amended by substituting for paragraph 8(1)(c) the following paragraph:

“(c) an application for registration as a recognized market operator under subsection 34(1) of the Act;”.

**Amendment of Schedule 2**

3. Part I of Schedule 2 to the principal Regulations is amended—

(a) by substituting for the words “electronic facility” the words “recognized market operator”; and

(b) by substituting for the item “Registration of an electronic facility under subsection 34(1) of the Act” and the particulars relating to it the following item and particulars:

“

<i>Activity</i>	<i>Fee</i>
Registration of a recognized market operator under subsection 34(1) of the Act	RM5,000.00 for the application for registration

”.
