PERINTAH KASTAM (DUTI ANTI-LAMBAKAN) (PELANJUTAN) 2016

PADA menjalankan kuasa yang diberikan oleh seksyen 25 dan subseksyen 28(7) Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967

CUSTOMS (ANTI-DUMPING DUTIES) (EXTENSION) ORDER 2016

IN exercise of the powers conferred by section 25 and subsection 28(7) of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Extension) Order 2016**.

(2) This Order comes into operation on 21 April 2016.

**Extension**

2. The Customs (Anti-Dumping Duties) Order 2011 published in P.U. (A) 142/2011 on 20 April 2011 is extended from 21 April 2016 to 18 October 2016.
