ORDER 2016

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Juru-Jalan Duta-Bukit Raja Expressway, North South Expressway Central Link and Kuala Lumpur-Johore Bahru Expressway) (Amendment) Order 2016**.

(2) This Order comes into operation on 15 April 2016.

Amendment of Third Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Juru-Jalan Duta-Bukit Raja Expressway, North South Expressway Central Link and Kuala Lumpur- Johore Bahru Expressway) Order 2002 [*P. U. (A) 171/2002*], which is referred to as the “principal Order” in this Order, is amended in the Third Schedule, in Part B, in the title, by substituting for the words “RATES OF TOLL FOR THE PERIOD FROM 14 JULY 2009 UNTIL 14 APRIL 2016 FOR VEHICLES CLASSES 1, 2, 3 AND 4 AND RATES OF TOLL FOR THE PERIOD FROM 14 JULY 2009 UNTIL 31 DECEMBER 2016 FOR VEHICLES CLASS 5” the words “RATES OF TOLL FOR THE PERIOD FROM 14 JULY 2009 UNTIL 31 DECEMBER 2016 FOR VEHICLES CLASSES 1, 2, 3, 4 AND 5”.

Amendment of Third Schedule A
