PERATURAN-PERATURAN PASARAN MODAL DAN PERKHIDMATAN
(DANA PAMPASAN PASARAN MODAL) (CARUMAN) (PENGECUALIAN) 2016

PADA menjalankan kuasa yang diberikan oleh perenggan 378(2)(f) Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Dana Pampasan Pasaran Modal) (Caruman) (Pengecualian) 2016**.

Pengecualian

2. Seseorang pemegang Lesen Perkhidmatan Pasaran Modal bagi pengurusan kumpulan wang berhubung dengan pengurusan aset terhad kepada—

(a) amanah perniagaan; atau

(b) amanah pelaburan hartanah,

adalah dikecualikan daripada kehendak untuk membayar caruman kepada Dana Pampasan Pasaran Modal di bawah subseksyen 160(1) Akta.

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES (CAPITAL MARKET COMPENSATION FUND)
(CONTRIBUTION) (EXEMPTION) REGULATIONS 2016

IN exercise of the powers conferred by paragraph 378(2)(f) of the Capital Markets and Services Act 2007 [Act 671], the Commission, with the approval of the Minister, makes the following regulations:

Citation

1. These regulations may be cited as the **Capital Markets and Services (Capital Market Compensation Fund) (Contribution) (Exemption) Regulations 2016**.

Exemption

2. A holder of a Capital Markets Services Licence for fund management in relation to asset management restricted to—

(a) business trust; or

(b) real estate investment trust,

is exempted from the requirement to pay a contribution to the Capital Market Compensation Fund under subsection 160(1) of the Act.
