SOLID WASTE AND PUBLIC CLEANSING MANAGEMENT ACT 2007

SOLID WASTE AND PUBLIC CLEANSING MANAGEMENT (COMPOUNDING OF
OFFENCES) (AMENDMENT) REGULATIONS 2016

IN exercise of the powers conferred by section 108 of the Solid Waste and Public Cleansing Management Act 2007 [Act 672], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Solid Waste and Public Cleansing Management (Compounding of Offences) (Amendment) Regulations 2016**.

(2) These Regulations come into operation on 1 April 2016.

Amendment of regulation 2

2. Solid Waste and Public Cleansing Management (Compounding of Offences) Regulations 2011 [*P.U. (A) 309/2011*], is amended in paragraph 2(*b*), by inserting after the words “13(2),” the words “14(3),”.
