AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGECCUALIAN) (PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengeccualian) (Pindaan) 2016**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 11 Mac 2016.

**Pindaan Jadual**

2. Perintah Duti Kastam (Pengeccualian) 2013 [*P.U. (A) 371/2013*] dipinda dalam Bahagian I Jadual, berhubung dengan butiran 66, dalam ruang (2)—

(a) dengan menggantikan perenggan (x) dan (xi) dengan perenggan yang berikut:

“(x) Sapurakencana Energy Peninsula Malaysia Inc.;

(xi) Sapurakencana Energy Sarawak Inc.”; dan

(b) dengan memasukkan selepas perenggan (xvii) perenggan yang berikut:

“(xviii) Sapurakencana Energy Sabah Inc”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) ORDER 2016

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) Order 2016**.

(2) This Order is deemed to have come into operation on 11 March 2016.

**Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2013 [*P.U. (A) 371/2013*] is amended in Part I of the Schedule, in relation to item 66, in column (2)—

(a) by substituting for paragraphs (x) and (xi) the following paragraphs:

“(x) Sapurakencana Energy Peninsula Malaysia Inc.;  
(xi) Sapurakencana Energy Sarawak Inc.”; and

(b) by inserting after paragraph (xvii) the following paragraph:

“(xviii) Sapurakencana Energy Sabah Inc”.
