AKTA PENJARA 1995

PERATURAN-PERATURAN PENJARA (PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh seksyen 67 Akta Penjara 1995 [*Akta 537*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Penjara (Pindaan) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 Mac 2016.

Pindaan am

2. Peraturan-Peraturan Penjara 2000 [*P.U. (A) 325/2000*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda—

(a) dengan menggantikan perkataan “Ketua Pengarah” di mana-mana jua terdapat dengan perkataan “Komisioner Jeneral”; dan

(b) dengan menggantikan perkataan “Perintah Tetap Ketua Pengarah” di mana-mana jua terdapat dengan perkataan “Perintah Tetap Komisioner Jeneral”.

Pindaan peraturan 2

3. Peraturan 2 Peraturan-Peraturan ibu dipinda dalam takrif “banduan yang disabitkan” dengan memasukkan selepas perkataan “pemenjaraan” perkataan “termasuklah banduan yang dipindahkan ke Malaysia di bawah Akta Pemindahan Antarabangsa Banduan 2012 [*Akta 754*]”.

Pindaan peraturan 113

4. Peraturan 113 Peraturan-Peraturan ibu dipinda dengan memasukkan selepas subperaturan (2) subperaturan yang berikut:

“(3) Walau apa pun subperaturan (1) dan (2), peraturan ini tidak terpakai kepada banduan yang dipindahkan ke Malaysia di bawah Akta Pemindahan Antarabangsa Banduan 2012.”.

PRISONS ACT 1995

PRISONS (AMENDMENT) REGULATIONS 2016

IN exercise of the powers conferred by section 67 of the Prisons Act 1995 [Act 537], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Prisons (Amendment) Regulations 2016**.

(2) These Regulations come into operation on 15 March 2016.

General amendment

2. The Prisons Regulations 2000 [*P.U. (A) 325/2000*], which are referred to as the “principal Regulations” in these Regulations, are amended—

(a) by substituting for the words “Director General” wherever appearing the words “Commissioner General”; and

(b) by substituting for the words “Director General’s Standing Orders” wherever appearing the words “Commissioner General’s Standing Orders”.

Amendment of regulation 2

3. Regulation 2 of the principal Regulations is amended in the definition of “convicted prisoner” by inserting after the word “imprisonment” the words “including a transferred prisoner to Malaysia under the International Transfer of Prisoners Act 2012 [*Act 754*]”.

Amendment of regulation 113

4. Regulation 113 of the principal Regulations is amended by inserting after subregulation (2) the following subregulation:

“(3) Notwithstanding subregulations (1) and (2), this regulation shall not apply to a transferred prisoner to Malaysia under the International Transfer of Prisoners Act 2012.”.
