AKTA PERKONGSIAN LIABILITI TERHAD 2012

PERATURAN-PERATURAN PERKONGSIAN LIABILITI TERHAD (PINDAAN) 2016

PADA menjalankan kuasa yang diberikan oleh seksyen 91 Akta Perkongsian Liabiliti Terhad 2012 [*Akta 743*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perkongsian Liabiliti Terhad (Pindaan) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 Mac 2016.

2. Jadual kepada Peraturan-Peraturan Perkongsian Liabiliti Terhad 2012 [*P.U. (A) 462/2012*] dipinda dalam butir 14 dengan menggantikan perkataan “Untuk bekalan maklumat kepada mana-mana agensi Kerajaan” dengan perkataan “Untuk bekalan maklumat kepada mana-mana agensi Kerajaan Negeri dan badan berkanun Negeri”.

LIMITED LIABILITY PARTNERSHIPS ACT 2012

LIMITED LIABILITY PARTNERSHIPS (AMENDMENT) REGULATIONS 2016

IN exercise of the powers conferred by section 91 of the Limited Liability Partnerships Act 2012 [Act 743], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Limited Liability Partnerships (Amendment) Regulations 2016**.

(2) These Regulations come into operation on 15 March 2016.

Amendment of Schedule

2. The Schedule to the Limited Liability Partnerships Regulations 2012 [P.U. (A) 462/2012] is amended in item 14 by substituting for the words “For the supply of information to any Government agencies” the words “For the supply of information to any State Government agency and State statutory body”.
