LOANS GUARANTEE (DECLARATION OF BODY CORPORATE)
(FIC PROPERTIES SDN. BHD.) ORDER 2016

IN exercise of the powers conferred by section 3 of the Loans Guarantee (Bodies Corporate) Act 1965 [Act 96], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Loans Guarantee (Declaration of Bodies Corporate) (FIC Properties Sdn. Bhd.) Order 2016**.

(2) This Order comes into operation on 10 March 2016.

Declaration of application of the Act

2. The body corporate known as FIC Properties Sdn. Bhd. is declared to be a body corporate to which the Act applies.
