AKTA PEGAWAI-PEGAWAI DIPLOMAT DAN KONSUL (SUMPAH DAN FI) 1959

PERATURAN-PERATURAN PEGAWAI-PEGAWAI DIPLOMAT DAN KONSUL
(SUMPAH DAN FI) (PEREMITAN FI) 2016

PADA menjalankan kuasa yang diberikan oleh subseksyen 4(2) Akta Pegawai-Pegawai Diplomat dan Konsul (Sumpah dan Fi) 1959 [*Akta 348*], Yang di-Pertuan Agong membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pegawai-Pegawai Diplomat dan Konsul (Sumpah dan Fi) (Peremitan Fi) 2016**.

(2) Peraturan-Peraturan ini hendaklah berkuat kuasa bagi tempoh mulai 1 Mac 2016 hingga 31 Disember 2016.

Peremitan fi

2. (1) Fi bagi visa yang kena dibayar di bawah perenggan B Jadual Perintah Pegawai-Pegawai Diplomat dan Konsul (Fi) (No.3) 1962 [*F.L.N. 239/1962*] bagi butiran Republik Rakyat China diremitkan satu ratus peratus.

(2) Peremitan fi di bawah subperaturan (1) hendaklah hanya terpakai bagi pelancong yang merupakan warganegara Republik Rakyat China yang datang ke Malaysia bagi maksud lawatan sosial, tertakluk kepada syarat-syarat yang berikut:

(a) kategori pelancong adalah seperti yang berikut:

(i) pelancong individu;

(ii) pelancong berkumpulan; atau

(iii) apa-apa kategori lain yang boleh ditentukan oleh Ketua Pengarah Imigresen; dan

(b) dibenarkan tinggal di Malaysia bagi tempoh tiga puluh hari bagi setiap kemasukan tanpa apa-apa pelanjutan tempoh.

DIPLOMATIC AND CONSULAR OFFICERS (OATHS AND FEES) ACT 1959

DIPLOMATIC AND CONSULAR OFFICERS (OATHS AND FEES)
(REMISSION OF FEES) REGULATIONS 2016

IN exercise of the powers conferred by subsection 4(2) of the Diplomatic and Consular Officers (Oaths and Fees) Act 1959 [Act 348], the Yang di-Pertuan Agong makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Diplomatic and Consular Officers (Oaths and Fees) (Remission of Fees) Regulations 2016**.

(2) These Regulations shall have effect for the period from 1 March 2016 to 31 December 2016.

Remission of fees

2. (1) The fees for visa payable under paragraph B of the Schedule of the Diplomatic and Consular Officers (Fees) (No.3) Order 1962 [F.L.N. 239/1962] for the item People's Republic of China is remitted one hundred percent.

(2) The remission of fees under subregulation (1) shall only apply to a tourist who is a citizen of People's Republic of China who comes to Malaysia for the purpose of social visit, subject to the following conditions:

(a) the categories of tourist are as follows:

(i) individual tourist;

(ii) group tourist; or

(iii) any other categories which may be determined by the Director General of Immigration; and

(b) permitted to stay in Malaysia for a period of thirty days for each entry without any extension of period.
