FISHERIES ACT 1985

FISHERIES (APPOINTMENT OF AUTHORIZED OFFICER) ORDER 2016

IN exercise of the powers conferred by section 36 of the Fisheries Act 1985 [Act 317], the Minister makes the following order:

Citation

1. This order may be cited as the **Fisheries (Appointment of Authorized Officer) Order 2016**.

Appointment of authorized officers

2. The Minister appoints the Department of Marine Park Malaysia personnel specified in the Schedule as authorized officers for the purposes of this Act.
