PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini boleh dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuhraya Shah Alam) (Pindaan) 2015**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2016.

Pindaan Jadual Pertama

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuhraya Shah Alam) 1999 [*P. U. (A) 69/1999*], dipinda dalam Jadual Pertama—

(a) dalam Bahagian II, dalam tajuk, dengan menggantikan perkataan “KADAR TOL BAGI TEMPOH KONSESI DARI 15 JANUARI 2013 HINGGA 31 DISEMBER 2015” dengan perkataan “KADAR TOL BAGI TEMPOH DARI 15 JANUARI 2013 HINGGA 14 APRIL 2016 BAGI KENDERAAN KELAS 1, 2, 3 DAN 4 DAN KADAR TOL BAGI TEMPOH DARI 15 JANUARI 2013 HINGGA 31 DISEMBER 2016 BAGI KENDERAAN KELAS 5”; dan

(b) dengan memotong Bahagian III dan IV.

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(SHAH ALAM EXPRESSWAY) (AMENDMENT) ORDER 2015

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Shah Alam Expressway) (Amendment) Order 2015**.

(2) This Order comes into operation on 1 January 2016.

Amendment of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Shah Alam Expressway) Order 1999 [*P. U. (A) 69/1999*], is amended in the First Schedule—

(a) in Part II, in the title, by substituting for the words “RATES OF TOLL FOR THE CONCESSION PERIOD FROM 15 JANUARY 2013 UNTIL 31 DECEMBER 2015” the words “RATES OF TOLL FOR THE PERIOD FROM 15 JANUARY 2013 UNTIL 14 APRIL 2016 FOR VEHICLES CLASSES 1, 2, 3 AND 4 AND RATES OF TOLL FOR THE PERIOD FROM 15 JANUARY 2013 UNTIL 31 DECEMBER 2016 FOR VEHICLES CLASS 5”; and

(b) by deleting Parts III and IV.
